Official Rules for KLBC New Year New You Contest

Note: This contest is intended for participation in the United States only, and shall be governed by and construed in accordance with U.S. law without regard for any applicable conflicts of laws rules. Do not enter this Contest if you are not located in the U.S. at this time.

NO PURCHASE NECESSARY

ENTRY: Listeners may sign up at the Diet Dr. Pepper display at the Wal-Mart Super Center in Durant. Entries should be limited to one per person per day.

SELECTION OF WINNERS: One name will be randomly selected *on February 14, 2012* with KLBC the final arbiter for eligibility.
